Grand Challenge cup for highest place junior in Class 1

Mariolino Trophy to be presented to the highest placed ex-racehorse in Class 2A or B.

If tied, winner is closest to optimum XC time.

It is essential that you advise when entering if you are a junior, ex racehorse or member when entering to ensure you are put in the right section to qualify.

### **RULES**

All persons attending the event do so at their own risk and BRC/the Sid and Otter Valley RC Committee nor the Land Owners do not accept any liability for any accidents, loss, damage, injury or illness to horses, owners, riders, spectators, land or any other person or property whatsoever, how so ever caused.

The Organisers reserve the right to amalgamate, split or amend classes as required.

Classes may be run in a different order to the schedule. It is likely that class 1 will run last.

To be judged under current Riding Club rules, a copy of which will be available at the Secretary's office.

In the interest of safety, other than due to a technical elimination, any combination failing to complete the show jumping or accumulating in excess of 24 jumping faults will not be allowed to ride the cross country. No exceptions.

The judge's decision is final.

It is the riders responsibility to make sure they comply with the current BRC hat rules available online prior to the event. They may be tagged for BRC, BE or PC and must be presented for inspection at the secretary's office with Body Protector.

Hats must be worn at all times while mounted, with a harness properly adjusted and fastened.

It is the riders responsibility to ensure they wear a correctly fitting body protector to at least **Level 3 year 2009** or after and is compulsory for cross country, and recommended that it is worn outside clothing. It is also strongly recommended for show jumping. Exo Body Cage BETA level 3 2000 are allowed but must be advised to the secretary and a key must be available to First Aiders.

Medical armbands must be worn for cross country.

Organisers reserve the right to withhold a proportion of the entry fee if the event is cancelled due to adverse weather.

No entry will be accepted without the full entry fee.

In the event of any delay on the day due to unforeseen circumstances no refund will be made.

Safeguarding Officer contact details will be displayed in the secretary's office.

To qualify as a SOVRC Member, subscriptions must be paid by the closing date. All BRC members will be covered by their BRC Insurance whilst attending BRC events. Non-members are not covered by the BRC insurance policy. It is mandatory for anyone attending this event to have third party insurance. It is the riders responsibility to ensure that if making an entry they do have the necessary third party insurance in place.

Anyone failing to comply with the Rules or Health and Safety Policy will be asked to withdraw. Abusive behaviour will not be tolerated under any circumstances.

### **HEALTH AND SAFETY**

All who attend the event are responsible for ensuring that they conduct themselves so that they do not put themselves or anyone else at risk. Vehicles must be parked so as not to cause obstruction.

Members of the public are requested to keep clear of horse areas and to avoid behaviour which may alarm horses.

Dogs must be kept on a short lead at all times.
