BLS Course Contents, Delegate Numbers Per Course & Delivery Details:

From January 1st 2017, the use of a Defibrillator now forms a part of the First Aid at Work (FA@W) accredited qualification for delegates who are either attending for the first time or are renewing their current qualification. The FA@W certification lasts for 3 years. To allow for employees whose FA@W qualification was achieved in 2015 or 2016, Kays Medical recommends that they, along with other employees expressing a desire to be more informed, attend a 3 hour BLS training course.

Defibrillators are proven to save lives and are therefore an invaluable addition to the Member's Health and Safety provision for your employees. Once one (or more) is installed in their workplace, the 2015 UK Resuscitation Council Guidelines recommend that you formally train First Aid qualified personnel in its usage.

Our course teaches the essential skills that a Powerheart G5 Defibrillator operator needs & will give delegates the confidence to know what to do in an emergency. Specific details of the the Member's Emergency Response Procedures will also be referred to during each course to ensure continuity of message for the company & your employees.

The Powerheart G5 Defibrillator is intuitive & simple to operate for a Rescuer whilst delivering advanced therapy to the patient ahead of the Emergency Services arriving at the scene. The course contents will help the Member's employees 'hands on' experience of 'what to do' if they are called upon.

No previous first aid knowledge is needed to attend an AED course.

Each course will last for 3 hours & accommodate 12 delegates at each.

Providing an understanding of Sudden Cardiac Arrest.

The types of SCA.

Patient assessment.

Providing an understanding of the Powerheart G5 Defibrillator provided.

1. Outright Capital Purchase:

An authorised Purchase Order will be required from the Member quoting the value of the required AED Package(s) along with the delivery address, a contact name at each location & telephone number will be required.

Deliveries will be made individually or to multiple locations via our designated courier & a signature will be required at each delivery location for security & delivery tracking purposes

Upon delivery completion an invoice will be raised & sent to the specified address & contact person. This will fall due for payment 30 days from the date shown on the invoice.

External Wall Storage Cabinet Installation

If required, we can arrange for the External Wall Storage Cabinet to be connected to a 240V powersource & attached to a building. The work will be completed by a fully qualified electrician. The cost will be invoiced by Severn Group Limited. The cost shown (which cannot be included within a Lease Agreement) may vary slightly according to any site nuances. Individual course arrangements, dates & times can be arranged at each Member's location by Sonia Douras & her colleagues within the Kays Medical Training Division.

2. Lease Option:

The Lease Option illustration (details below) is subject to successful commercial credit checking by Shire Leasing plc.

Upon successful completion a Lease Agreement document will be sent by Shire Leasing PLC to an authorised signatory at the Member to sign, complete & return to Shire Leasing PLC. Once received, Shire Leasing will instruct Kays Medical to deliver the required equipment to the addresses provided.

The Lease Agreement period for the illustration is 4 years with equal 16 x equal payments being made by Direct Debit (DD) to Shire Leasing PLC.

The 4 year Lease illustration also includes the cost of replacement electrodes when they reach their expiry date after 2 years (1 x set of adult ICPR & 1 x set of adult electrodes to act as spares).

This means that, unless an AED is used in a emergency, there will be no additional costs for the Member to pay. After a device is used in a rescue, a replacement set of adult ICPR electrodes (product code XELAED002A unit cost £75 plus VAT) & a replacement Rescue Ready Kit (product code XKTAED001A unit cost £18.75 plus VAT) should be ordered by sending an e-mail to: sonia.douras@kaysmedical.com

3. At the end of the 4 year Lease Agreement, the Member will be given the option to purchase the Defibrillator Package(s) from Shire Leasing PLC. The cost for this will equate to the equivalent of 1 month's lease cost **OR** to return the AEDs, take out a new Lease Agreement & receive brand new replacement AEDs meaning that the Member is always equipped with the latest in AED Rescue Ready technology which is no more than 4 years old.
