3: Matters Arising from the ALM

Area Junior Liaison Rep – Anya Hitt unavailable! But understood she is now at College, and no longer a Junior. The concept of a Junior Area Liaison rep is understood to be a Head Office idea, however no Job Description exists. Although not all Clubs have Juniors, a significant proportion of Area 12 Clubs do. Ilfracombe offered to provide two Juniors for the role, Charlie (17) and Harry (16) Pocock, both are social media aware.

Training Day for Stewards - new date to be advised by BRC after the hotel for the original date was closed by the Authorities! Zoom meetings are not so suitable for this type of event. Ongoing.

Costs of Competitions (including pre-entries) Many Areas fill their Qualifiers and are viable. Area 12 as more remote have fewer people willing to travel to Nationals, so entries would be down unless the Qualifiers were boosted by non-Qual entries. Breakdown for pre-entries (and actual entry fees for the Finals) needed as costs are causing concern – do the various Nationals make a profit, offsetting Affiliation expenses, or a loss? Transparency would be nice: Chris Beer to request breakdown of BRC accounts.

Membership cards now emailed – members use these locally as some shops offer discounts etc. Members not on email can give another member's email to print for them.

Area Website – Carolyn Price has joined the Area Committee with sole aim to maintain the Website. Committee contacts are now on there; links to schedules, Equo entries, etc.

4: Chairman's Report

Sally welcomed North Devon Riding Club, recently reformed and officially affiliated.

Competitions are getting back to taking place, albeit as a 'new normal.'

5: Area Rep's Report

Chris reported nothing has changed since November's ALM. Hat standards will be changing for 2023; body protectors may be in addition.

6: Treasurer's report

Helen reported Areas are up to date with Area dues except for Kentisbeare and Royal Navy. Weymouth had sent a cheque for £6-40 despite not being billed, it was not known whether they still existed? Peter to establish contact

Savings account £8,000 had accrued 27p interest (!); current account held £4,021 although some entries from recent Qualifier needed to be transferred from online booking system Stripe.

A laptop computer and printer had been bought, with mobile access by SIM card for online scoring, 2 years access, £532 the lot! Noted that data allowance will cost an ongoing £45 every 2 years. This is available for all Clubs to use.

Timing equipment also exists, similarly available, held by Charlotte Warman, and stopwatches, held by Chris Beer.

Area Rosettes – stocks have been run down, there was some discussion about whether it is easier for organising Clubs to just use their own for the non-Qual Area Championships? No strong feelings against this were expressed.

Helen reminded everyone of the 10% 'tax' on profits for running Qualifiers, above the first £200 profit. ETSW had thought they had made a loss on the Combined Training qualifier, which Area would have made good – it actually turned out there was a small (£40) profit.

7: Training Report

Lucy reported the February camp went well, venue (David Broome's yard) was good. It made a small profit despite the Training Grant being available for any shortfall.

The theme for this year's Training events is to get lots of different things happening in one venue, with prestigious trainers, including sports psychology. Aiming also for course-walk trainers at Qualifiers, to walk the course at the published times, to be paid for by the BRC Training grant.
